OnCommand Connection integrates with a customer's existing telematics provider, regardless of vehicle make, to transmit performance and diagnostic-related data to the system. OnCommand Connection then interprets this data to create easy-to-understand vehicle health reports with recommended actions based on operating conditions and the severity level of any fault codes. Visibility into the operational health of the school bus empowers fleet managers to understand the severity of vehicle issues and determine the appropriate action.

Hardware and data from other telematics service provider partners will be partially covered by this program. The credit bundle goes into effect on new orders placed since July 1, 2015 in the U.S. and Canada, and will be available to customers buying directly through the IC Bus dealer organization.
